1. WELCOME

The Chair, Georgie Brimer formally welcomed all in attendance and declared the meeting open at 10:06am.

DUSA President's Address:

Good morning everyone

Before we begin, I would like to acknowledge that as we gather for this meeting physically dispersed and virtually constructed, we should take a moment to reflect on the meaning of place and in doing so recognise the various traditional lands on which we do our business today.

Thank you everyone for taking the time to be here at today's AGM.

I have been a DUSA member since before Covid and have seen a lot of changes since 2019. To give a snapshot of DUSA in 2023, I will focus on three main aspects.

Events back on campus:

With the return to campus, we are almost seeing a pre-covid level of students back on campus now and attending our events, such as O'Fest, Pride Week and Self Care week, along with our other usual events such as Beats and Eats, Mystery Bus, and O'Camp which was shortened to O'Day this year due to budgetary constraints. Having these events back on campuses is making for a vibrant campus again after Covid and providing opportunities for us to engage clubs and club leaders in this space, which is benefitting our events by getting more student leaders to help run events and also benefitting clubs by giving them more exposure and increasing their membership base. And of course, clubs themselves have been successfully running their own events as well.

Education:

Getting a quality and accessible education is increasingly something that students are more and more concerned about. Student Council and particularly myself as President, do not represent every single student demographic, which is why we created the Education Committee as a way of funnelling information from the wider student population from different backgrounds, faculties, international and domestic to Student Council so that we are adequately informed of a wide range of issues affecting students.

Welfare:

There are many welfare issues being faced by students this year, such as the increased cost of living, food insecurity and financial insecurity. DUSA has been increasing our welfare and food packages with the free food pantry, chill out trolley (successful enough to be at both Geelong campuses), and the survival centre are just some of the ways in which DUSA provides welfare to students to alleviate some of this stress. DUSA Advocacy team do amazing work every year providing welfare to students in need and supporting them with individual cases. They also continue to send out surveys to get an accurate idea of the number of students facing financial and food insecurity and use that data to determine the best way to help them and to inform the University. 5. SPECIAL RESOLUTION

The Chair advised that she would now speak for the resolution to change the DUSA Constitution.

The Chair spoke to the proposed special resolution to change the constitution, advising that these amendments were required due to the University's recent change in structure for Cloud Campus students to Online students attached to a physical campus, and that we need to ensure that our structure and regulations are aligned with this new structure.

The Chair advised she has recently held individual meetings with the current Cloud Campus representatives to explain why these changes are necessary. The Accessibility and Services Representative positions across Burwood, Geelong and Warrnambool campuses will be renamed the Accessibility and Online Student Representative and this role will be the voice of online students.

The Chair advised the constitutional amendments had been provided in the Notice of AGM and in the agenda and asked if anyone had any questions regarding these changes or if anyone present wanted to speak against the changes.

Questions and discussion ensued.

The Chair clarified that online students attached to a physical campus will have the ability to nominate for any position available on their campus committee during the elections. They will also be able to create an informal DUSA online students committee if they wish to do this.

The Chair advised that if everyone present was happy to proceed to a vote she would now move a motion to approve the changes to the Constitution.
