DUSA / TAC Road Safety Campaign – 2026

Road Safety Competition Terms and Conditions

In partnership with the Transport Accident Commission (TAC), in 2026 DUSA is continuing a road safety campaign to help change the way that the Deakin University student community thinks and acts on our roads.

As part of this campaign DUSA is inviting current Deakin University Students to complete a road safety quiz and in doing so, they will automatically be entered into a competition to win x1 of 3 \$1,000 cash prizes.

The Promoter

The promoter of the competition is Deakin University Student Association (DUSA), Building H, 221 Burwood Highway, Burwood VIC 3125

- The information on how to enter forms part of these Terms and Conditions. By entering, entrants agree to be bound by these Terms and Conditions and entries must comply with these Terms and Conditions to be valid.
- This competition is governed by the laws in force in the State of Victoria, Australia.

The Competition

- The competition is free to enter and is open to current Deakin University Students only. Students must complete the Road Safety Quiz in the manner set out in the Terms and Conditions.
- Staff employed by Deakin University or DUSA and their immediate family members are not eligible to enter the competition.

Competition Period

- The competition will commence on 9 February 2025 and conclude at 11.59 pm on Friday 20 March.

Prizes

- There are x3 \$1000 cash prizes to be won

How to enter

- Entrants must be a current Deakin University student.
- Entrants must complete the Road Safety Quiz in its entirety.
- Entrants must be following DUSA on facebook and Instagram @yourdusa
- Entrants must only complete the Road Safety Quiz once

Selection and Notification of Winners

The potential provisional winners will be chosen by a DUSA representative at random.

The potential provisional winners will be contacted on the mobile number provided on their entry form.

If DUSA is unable to contact the potential provisional winners within 48 hours, we reserve the right to pick a replacement potential provisional winner.

The potential provisional winner must consent to the Promoter seeking from VicRoads and VicRoads providing to the Promoter details of their driving history for the purposes of confirming whether they are an Eligible Entrant. The potential provisional winner must supply their full name, date of birth and postcode to enable a licence check to be completed. On successfully passing the licence check, the provisional winner will then be notified that they have won.

- The winners will be announced on DUSA's Facebook and Instagram on Friday 27 March.
- The winners will be published on the DUSA website.
- The promoter will notify the winners as to when and where the prizes can be collected or delivered.
- Prizes are not transferable.
- The winners must comply with the Student Code of Conduct.
- DUSA's decision is final and binding and no correspondence will be entered into.
- DUSA accepts no responsibility for late, lost or misdirected entries or other communication. Entries will be deemed void if forged, manipulated or tampered with in any way.

Publicity

- Entrants consent to DUSA and the TAC using their name, image or voice for promotional purposes and must agree to make themselves available for a photograph and interview in the event that theirs is the winning entry and if requested by DUSA or the TAC.
- Winners consent to their name and photograph being published on DUSA and TAC social media and other digital channels if requested.
- By entering the competition, entrants are agreeing to receive communication from DUSA and the TAC. Entrants may opt out of receiving communication at any time.

Privacy Collection Use and Disclosure Statement

Personal information provided to DUSA by entrants will be used to notify the winners of the competition. A photograph of the winners may be published on DUSA and TAC social media channels including Facebook and Instagram and other digital channels such as TAC Tik Tok.

DUSA complies with the Privacy and Data Protection Act 2014 (Vic) in its treatment of personal information. Entrants have a right to access their personal information held by the University.
